Another Report on the Loss of the Bow by Shipmate Bernie Kern

Bernie writes . . .

The night of October 27th the OZBOURN was in the Yellow Sea with the T.E. CHANDLER, two other destroyers and USS ST. PAUL playing war games. We were trying to locate a US cruiser and four other destroyers. About 2130 hours the skipper, Captain Norman E. Blaisdell, received a signal to change course 180 degrees. The captain got on the squawk box and asked the command ship to repeat the signal. The admiral understood that Captain Blaisdell was receipting for the signal. The admiral executed the turn. The next thing that I knew, I was looking up to see the T.E. CHANDLER plowing into the bow just forward of mount 51. She bounced off, hit again just forward of the bridge, and then hit again at the after signal light where I was working. The blow knocked me across the signal bridge and I was holding onto the starboard signal light to keep from going over the side. I looked down to the water and saw the bow of our ship floating by.

The next day the headlines in the San Diego Union had USS OZBOURN sunk with all hands. Not True!

We backed down to Tsingtao where the tender put a plywood cover over the hole. We left there for the shipyard at Yokosuka, Japan where Mount 51 was removed and placed on the dock. I'm told it's still there today! From Japan (Continued on page 2 — Bernie)

(continued from page 1 — Letters) I always was messing around on the bridge - 'Mine dead ahead, all engines reverse!' I hollered. Mr. Seacord said 'O'Halloran, do you mean it?' I believe he beat Cheever to reversing the engines. When the skipper hit the bridge, which was darn fast, and was informed of the situation, he asked who spotted it. He looked up at me and I said 'it's out there, Captain.' He picked it up with his glasses. After maneuvering around and pouring plenty of ammo into it, it would not blow. Someone said it looked like a giant fender. Anyway, we secured from quarters and before he left the bridge, the Captain gave me a 'well-done.' Thirty some years later I sent for about \$140 worth of OZBOURN deck log for every day I spent on her. It gave the same story that Paul Logan provided. At the top it said 'Classified,' at the bottom it said 'Re-Classified.'

John writes "... One of my first jobs aboard the OZBOURN (known as the 'Dirty O' to us at the time) was, as torpedoman striker, to paint the depth charges. After painting the charges with yellow chromate, I was standing at quarters next to Mount 53 when I looked over at the ones nearest to me on the starboard side and noticed one was missing. Thirty days from the day we went into drydock we were back at sea testing our new mount at the San Clemente range. Then to San Diego for Captain Blaisdell's court martial.

"JB" Julsis (sic) Bartholomew Chastine was quartermaster of the watch for GQ. The court asked "JB" what the OOD was doing. He told them that the OOD was standing around with his thumb up his ____. That didn't go over too well. "JB" was a southern gentleman and he apologized to Mrs. Blaisdell who told him "'JB,' tell it like it was."

When the court martial was over, Commander Blaisdell walked out a brand new captain. "JB" was the first man to salute him and the "old man" gave him a brand new silver dollar!

(continued from page 2 — Letters) the starboard side, thinking someone had moved it for a joke. There was also one missing on the port side. There were traces of yellow chromate on the lower life line and on the edge of the hull on both sides. Somebody had launched two depth charges! After reporting this to our division officer, who then told the skipper, a diver was hired to go down and retrieve the depth charges. The skipper restricted the whole ship until somebody would come forward and confess. The guilty parties turned out to be a TM2 and a GM2. I don't recall what punishment they received other than restriction. This happened while we were moored at the Charleston Navy Shipyard prior to sailing for the west coast.

"While at the shipyard I met our first ship's mascot, a small pup brought aboard in a chief bos'n's pocket. After being aboard for awhile, he ('Sparky') would run aft to the fantail, where my GQ station was located, whenever the alarm sounded. He was strange because he didn't know how to act like a dog (except for sex — you had to be careful when crossing your legs in front of him). He slept on his back in a bunk like we did, ate fruit and vegetables, and drank coffee! When we arrived at China, the squadron commander made us send him back to the states on board a destroyer. He was put in kennel in San Diego until we returned."

John says he has other sea stories for a later date.

Thanks to the loan by Shipmate Mike Quinn of a volume entitled US Navy Destroyers at War 1941-1945 (Sea Classics Special, 1984), I found reference to a TM 1/c A. C. O'Halloran who was serving ON (his word!) USS INGRAHAM (DD694). "A. C." (I assume our A.C.
