Minutes of the 11th Biennial Reunion Business Meeting

28 September, 2013 - San Diego, California

At 0830 hours, 28 September 2013, the Business Meeting of the USS Ozbourn DD-846 Association was called to order by Association President Guy Posey with 37 shipmates in attendance. All in attendance joined in the Pledge of Allegiance to our Flag.

The minutes of the 2011 Business Meeting held in Philadelphia were read by Recording Secretary Ken Keene. With no additions or corrections, motion was made to approve the minutes as read; vote to approve passed by the majority.

In the absence of the Association Treasurer, the Treasurer's Report was given by Guy Posey. The current balance of the Treasury to date is \$11,630.74 with an outstanding reunion debt of approximately \$2,000.00 leaving an approximate post reunion balance of \$9,630.74. Motion was made and seconded to approve the Treasurer's Report as read; vote to approve passed by the majority.

Jeff Parker, Corresponding Secretary, gave a report on the "Fireball" newsletter. When the cost of mailing the "Fireball" was reported, a discussion of e-mailing was brought to the floor. It was pointed out that it still is not practical as was determined in the previous meeting due to the lack of correct e-mail addresses. Also in discussion of non -profit mailing rates, it was pointed out that there is a minimum number of units that must be mailed at a time and we are very close to that minimum. All non-profit mailing must be done from a USPS Distribution Center which could be impractical for the Editor. Motion was made and seconded to approve the Corresponding Secretary Report as read; vote to approve passed by the majority.

Rudy Boff, the Ship Store Operator reported that he has reviewed the costs of merchandise and the shipping costs. It is necessary at this time to increase both the prices of items in the ship store and the shipping costs in order to show a small profit. Motion was made and seconded to approve the Ship Store Report as read; vote to approve passed by the majority.

The Reunion Report was given by Jeff Parker. The preliminary finances were \$24,089.00 collected from 104 registered guests. Expenditures were broken down to what each tour cost, as well as the Banquet and the Hospitality Room. There were some refunds made to guests who had to cancel. The final balance will not be known until after the reunion and final bills are totaled. Jeff reported that the Reunion will finish in the Black with a few hundred dollars profit. Motion was made and seconded to approve the Reunion Report as read; vote to approve passed by the majority. *Note: The 2013 Reunion did indeed end in the Black with a positive balance of \$115.59*.

Old Business

Signage on the Joseph W. Ozbourn Memorial Highway:

At the 2011 Business Meeting, Rudy Boff reported that a family member of Joseph Ozbourn had informed him that the Herrin, IL. VFW had been successful in having County Route 2 named "The Joseph W. Ozbourn Memorial Highway" and would seek further updates about signage. Randy Humphries reported that a former shipmate travelling in the Herrin, IL. area informed him that the signs designating the main highway leading to the city "The Joseph W. Ozbourn Memorial Highway" are in place.

There was no further Old Business brought to the floor.

New Business

Dues:

Association Vice President Randy Humphries brought up the subject of Membership Dues. The dues have been set at \$10.00 per calendar year since the inception of the Association in 1991. Due to the increase in postage, printing the newsletter, dues in the American Military Reunion Foundation and the cost of maintaining the Association Web Site, it was determined by the Association Officers that \$10.00 is no longer sufficient to cover the costs of the Association. It was pointed out that all current paid dues will be "Grandfathered" with no additional payment necessary. On recommendation of the Association Officers, motion was made to increase the dues to \$15.00 per calendar year effective immediately; vote to approve passed by majority.

Membership:

Jeff Parker opened a discussion of an Associate Member. He had received dues payment from a shipmate to have the son of a former Commanding Officer of the USS Ozbourn included on the roster of members and to receive a newsletter. Ken Keene read Section 3, Paragraph B from the Association Bylaws which states this is permissible upon majority vote by the Association membership. It was also pointed out that since we are a 501 C 19 non-profit veteran organization that 90% of the membership must be veterans. The Recording Secretary assured that we are well above the IRS veteran membership requirements. The secretary is to contact the Associate Member to determine if he is a veteran or not. Motion was made and seconded to accept the Associate Member; vote to approve passed by majority.

Next Reunion:

President Guy Posey pointed out that the 2015 Reunion should be held in the center part of the country in keeping with Section 7, Paragraph 2 of the Association Bylaws. A request for volunteers to serve on the next reunion committee was made. Mike Ward, Harold McKeehan and Guy Posey volunteered with Guy Posey being the chairman.

Election of Officers:

It was pointed out that none of the current slate of Association Officers had expressed a desire to resign. A request for volunteers or nominations from the floor for President, Vice President, Recording Secretary, Treasurer, and Corresponding Secretary yielded no candidates for any of the offices. Motion was made and seconded to approve the current slate of Association Officers for another 2-year term; vote to approve passed by majority.

Donations:

Members were reminded that at the 2011 Business Meeting there was a discussion of requesting a financial report from the proposed recipient to insure that our donated monies were used for the purpose which the Association intended. In addition, the reminder was printed in the Summer 2013 edition of the "Fireball". Ken Keene gave a brief report on the use of funds donated to the "Tin Can Sailors", Thomas J. Peltin Destroyer Museum Grant Fund and requested a \$500.00 donation, the same amount as donated in previous years. No other financial reports were available and no other donation requests were made.

Guy Posey reported that the Association Officers believed that a revision to the Association Bylaws should be made limiting the total amount of donations to a percentage of the Treasury Balance and requiring proposals for donations of the Association monies be made 90 days prior to the business meeting accompanied by a financial statement. The


Association Officers would then review all requests to determine the legitimacy of the recipient and determine if the total dollar amount of all requests is in line with the percentage of the Treasury Balance rule. The proposed change to the

Association Bylaws will be presented at the 2015 Business Meeting for member vote to approve or reject. Motion was made and seconded to donate \$500.00 to the Tin Can Sailors and Thomas J. Peltin Destroyer Museum Grant Fund; vote to approve passed by majority.

Agent Orange:

Ken Keene read an article about Navy ships and presumed exposure to Agent Orange. The Ozbourn is presumed to have been exposed on dates in 1965, 1966 and 1971. Not only is it important to veterans with Agent Orange related disability claims but it can make a veteran eligible for a higher priority for care in the DAV health care system.

With no further New Business brought to the floor, the 2013 Business Meeting was adjourned at 1002 hours.


