### **MILITARY EXCHANGE PRIVLEDGES TO ALL VETERANS**

As a reminder to All Hands, the Department of Defense policy change regarding access to Military Exchanges is now in place. As reported by **Reed Jones, Lt. (65-67)**, in the 2017 Spring Edition, the new policy affords all Honorably Discharged Veterans from all branches of the U.S. Military, that had not previously had been given this benefit, eg: Retirees, can now register for **ON-LINE** access to the various military exchanges. You may now register with the exchange to make purchases on-line. *(Editors Note: I have personally registered by typing in "Military Exchange" and then follow the instructions. Once registered you may make purchases.)*

# AGENT ORANGE CLAIMS UPDATE BLUE WATER VIETNAM VETERANS ACT of 2019

Clearly, the subject of health related issues is of the utmost importance to us all as we are no longer young. Many of our Vietnam Era Shipmates have contracted varying heath problems related to the U.S. Government's use of herbicides such as Agent Orange during the Vietnam War.

Up until June 26, 2019, a veteran suffering from an illness attributed to Agent Orange, was required to show evidence of "Boots on the Ground". This of course included port stops by U.S. Navy ships where there was the possibility that any crewmember may have left the ship for any reason. This of course required requesting deck logs along with any other evidence for a specific date that the ship was in port. Clearly, a long and tedious search was required to prove that a shipmate's illness is related to a specific port visit.

(Editors Note: On behalf of our members, our **Association Secretary, Ken Keene**, spent several long and tedious hours in requesting Deck Logs and conducting research in an effort to obtain dates, along with other evidence showing the Ozbourn was in a port within Vietnam. We are all grateful for all of Ken's hard work.)

### Great News!

On June 26, 2019, President Trump signed into law, the **Blue Water Navy Veterans Act of 2019**. As a result of this legislation the VA Benefits have now been extended to Blue Water Sailors. According to the VA.gov, the act guarantees that veterans who served off the shores of Vietnam and were exposed to toxins such as Agent Orange, can access treatment and receive benefits from the VA.

According to the Veterans Administration website, VA.gov, The Blue Water Navy, (BWN), Vietnam Veterans Act of 2019, extended the presumption of herbicide exposure, such as Agent Orange, to Veterans who served in the offshore waters of the Republic of Vietnam between January 9, 1962 and May 7, 1975.

Beginning January 1, 2020, Veterans who served as far as 12 nautical miles from the shore of Vietnam, or who had service in the Korean Demilitarized Zone, are presumed to have been exposed to herbicides, such as Agent Orange, and may be entitled to service connection for any of the 14 conditions related to herbicide exposure.

The VA is also now able to extend benefits to children with Spina Bifida whose BWN Veteran parent have been exposed while serving.

# How to Determine if and when the USS OZBOURN DD846, was operating within the 12 Nautical Miles of Vietnam during your dates of service.

Although there may be several directions a veteran may go in locating information that while serving on a particular U.S. Navy ship, during the required dates and location off the coast of Vietnam, **Association Vice President Mark Beaulieu**, has found a website for **H& P Hill & Ponton Disability Attorneys**, that have included an interactive Vietnam Blue Water Veterans Map. One only needs to pull up the on-line map, insert the USS Ozbourn DD846 and the dates that one served onboard. *(Editors Note: Clearly, the Association cannot endorse any commercial enterprise and would recommend to any member to conduct due diligence when seeking any information from any entity.)*
